**Apologies and Introductions/Declaration of Interest/
Code of Conduct**

Introductions were made and apologies were shared by BB as above. JB asked members to declare any declarations of interest prior to the meeting.

Code of Conduct

KL explained that the Steering Group have asked for Code of Conduct to be mentioned at each Healthwatch meeting. The full version is available for the group and BB read out the main points as follows:

- To conduct ourselves in a reasonable and responsive way to other members and guests

To show courtesy and respect to other members and guest speakers.

- To ensure we are speaking on behalf of the people we represent and not our own personal experiences or views, if it is a personal experience or view to declare it.
- To declare any conflict of interest

Guest speaker – Vanguard Programme Manager, Joan McIntyre,

Indepth presentation by JM the Programme Manager for The Walton Centre, Neuro Network Vanguard Programme. During the presentation JM explained that they are implementing a programme which will provide Clinicians such as Trust Doctors and GP's/nurses who need help when seeing patients with head or spinal injuries or fits/seizures receive the best treatment quickly in the right place. For example, they have established an advice line facilities at The Walton Centre for both GP's and patients/carers to receive advice and guidance to manage neurological conditions safely and are also trying to establish local community support via their highly trained Integrated Neurology Nurse Specialist Nurses (INNS) who are currently working with many Community Providers across Merseyside and Cheshire such as Lancashire Care Trust to support patients living with neurological conditions within the community.

The group felt that they would like more detail on what this means for the patients in Sefton and at a detailed local level. JM has kindly agreed to come and chat as often as we need and will keep Healthwatch updated on progress.

Question IM asked if they are there any links working through CCG.

Answer: JM informed she works very closely with all key partners such as CCG Commissioners and meets up regularly with Sefton Commissioning team

Question: CB asked about KPI's after March 2018

Answer: JM explained that there is a robust evaluation process that underpins the whole programme and we have set KPIs which we work to. JM also explained that the programme team work closely with Key Partners regarding the continuation of the work and maybe future funding opportunities going forward.

CB stated that there is a need to present evidence of cost savings.

Answer JM agreed and stated that CCG's are seeing the benefit and that there are 11 projects within the programme, all of which is evidenced and Sefton CCG are working with us to implement these projects locally and it all seems to be going well so far. NHS England are promoting us as a New Care Model exemplar and within Sefton we are working with primary care GP practices, CCGs, Locality teams regarding communication and engagement.

IM stated that at The Big Chat Events they were keen to educate people better and stated that patient experience is key.

DT stated that this was the first time that he had heard about this. JM said that they are working with as many groups as they can in order to reach the general public.

Notes and actions from the last meeting

The notes were agreed as true and accurate with one adjustment: Justine Shenton's name appeared twice within the attendance list. The second entry has now been removed.

Action Log Update from the last meeting

- **Waiting times for Podiatry Services**

Work is being planned for Healthwatch Sefton to work with Lancashire Care to carry out further consultation around the Podiatry Service

- **Adult Social Care Delays**

No feedback to report at present.

- **St Marks Medical Centre**

After the Practice stating that they are constantly looking at ways of improving the appointment system. The Monitoring & Scrutiny Panel will be keeping an eye on this and as BC is on this Panel he will keep us updated

- **Southport Listening Event**

Hard copy has now been emailed to the group

- **Access to Pharmacies**

People First Merseyside fed in experiences and a report on the findings has gone to CCG and the response is expected by the end of September

- **Care after discharge from hospital**

This issue was raised again at the recent Orthopaedics Event and ENT have taken this back for consideration.

- **Equipment not being replaced to aid a person with a Disability.**

SL gave an update on this action: The demand for the service is increasing and they need to look at how things can be done differently.

SL referred to the online questionnaire and stated that the review is on-going. DT asked if he could be supported with the completion of the questionnaire. SL offered her support.

ACTION BB to supply SL with contact details for DT

- **Lack of Public conveniences in Formby**

List of community venues where they have opened up their conveniences to the public provided by JS was shared with the group.

- **GP's Retiring in Sefton**

An update was provided from Liz Thomas, Health Education England who attended the June Steering Group and stated that

they are nationally mandated to recruit an extra 5,000 by 2020. She stated this has been a long standing difficulty and that they are working to meet these targets.

Tea & Toast Event (Transport)

This will not go ahead as BC&JS have been doing a piece of work through the Older Persons Forum therefore this would become a duplication. BC can feed back outcome.

Consultation/Pharmacies

Locality Reps will be raising awareness of Healthwatch to local Pharmacies and if possible leave leaflets and posters.

One of Lancashire Care's key promise was to carry out a robust patient engagement programme and develop joint partnerships across the locality. IM was grateful for the support shown and offered by

Healthwatch Sefton. He will attend the EPEG December meeting to share what's been happening.

They are in the process of re-designing services and all teams are being re-structured. They want to pick on the Podiatry experiences that are currently being shared across north Sefton and work towards alleviating the problems as much as possible
